He joined TEPPFA Executive Committee in 2021 as the representative of KRV and is active within various TEPPFA Working Groups and Task Forces with a specific focus on Sustainability and Circular Economy topics. He is also advisory committee member of <u>PE100+ Association</u> and in the advisory board of <u>3R - Magazin für den Rohrleitungsbau</u> <u>und effiziente Leitungssysteme</u> (3R - Magazine for pipeline construction and efficient pipeline systems).
